## Zurich Minor Athletic Association <br> 50/50 Lottery License Rules of Play

## The Rules of Play must be posted at the location of the draw and be readily available to the public (ie. Licensee website, communicated at time of ticket sale).

1. A maximum of 5,000 tickets will be sold. Ticket price will be $\$ 5.00$.
2. The draw will held at 7:00PM on Wednesday, August 28,2024 at 37550 Zurich-Hensall Rd, Zurich, ON NOM 2 T0
3. Deadline to purchase ticket will be 6PM on Saturday, August 24, 2024
4. The prize will be equal to $50 \%$ of the gross tickets sales up to a maximum amount of $\$ 12,500$ and payable by Cheque issued from a designated lottery bank account.
5. No other prizes will be awarded.
6. Only tickets that have been paid for and/or have been verified as paid for are eligible to be entered for the draw.
7. All purchasers of tickets, and all winners, must be at least 18 years of age. Tickets may not be advertised, offered for sale, sold or ordered from outside of Ontario. However, while they are in Ontario, residents of other countries or provinces may purchase raffle tickets sold under a licence issued in Ontario.
8. The Licensee will abide by the General Conflict of Interest Guidelines set out in the AGCO Lottery Manual - see notes to licensee.
9. Winning number will be notified by public announcement via a live video on Zurich Minor Athletic Association and Bean Festival Committee's Social Media Pages.
10. The prize will be awarded to the person who's information is recorded on the ticket stub drawn.
11. A bingo ball rotary bin container will be used and rotated 15 times at the end of rotation a ticket stub will be removed from the bin and the winner will be announced by reading out the information on the ticket drawn from the rotary bingo ball rotary bin.
12. Winning ticket information will be posted on the ZMAA and Bean Fest websites and social media.
13. The draw will take place at 7:00PM. A cheque will be made payable to person listed on ticket stub and made mailed to the mailing address listed on the ticket stub drawn.
14. Draw will be made by Lance Bedard. This person Is a neutral party who is 18 years of age or older, is not eligible to purchase a ticket or win any prize.
15. The 2 bona fide members in charge of, and responsible for, the management and conduct of the raffle and who are not eligible to win any prize are:

### 3.5.3. GENERAL CONFLICT OF INTEREST GUIDELINES

The following conflict of interest guidelines have been established to give the public confidence in the integrity of charitable organizations conducting lottery events. As this is a sensitive issue, licensees must be vigilant in preventing any possibility of a potential or perceived conflict of interest.

1. No member, principal officer or paid staff of an applicant organization may be involved, in any way, in the approval of a licence application and/or the conduct and management of a licensed event. For example, a member of a municipal council who is also a member of the applicant organization must refrain from offering an opinion or vote on the granting of the licence, must not sign the application and must not have any direct or indirect dealings or decision-making authority with respect to the licensed event.
2. No person assisting in the conduct and management of a lottery event may have any monetary interest in any card, ticket or bet, or have a chance to win a lottery prize in any way.
3. No designated member responsible for the conduct of the licensed lottery, or volunteers assisting with the lottery, may have any direct or indirect personal financial interest in the funds raised.

Licensee must provide this information. Note that the drum/box used for tickets must have ample space for all tickets to move around when rotated. A clear container provides ticket purchasers with the most assurance of the level of integrity of the event.

## \#13.

The licensee must determine how long they will wait before pulling another number. This may depend on the location, the event. Time of the final draw will also be determined by the location and event. Details must be included in your rules.
